



HOW NYS ALTARS OF WORSHIP CAME TO BE

God began speaking to Jane Lampkin in 1996 about His desire for ongoing, unified, corporate worship in New York State. She was able to hold one-time or extended worship events over the years but not ONGOING unified corporate worship throughout the state. But each event brought greater revelation about God's desire.

Over the years Jane served in several prophetic and worship ministries and in the early 2000s she served as Programs Administrator for a 24/7 harp and bowl ministry in Albany, NY, all were preparation and training for God's calling on her life.

God taught her that the key for NYS is to send Judah first and establish altars of worship throughout the state to disarm all ungodly altars. Praise and worship open heaven's portals for revelation and like in David's Tabernacle, NYS Altars of worship are to decree and declare in sound and song, God's call for NYS and our kingdom governmental authority.

The ultimate goal of NYS AOW is to establish altars of worship in every county of the state. God wants to gather the Ecclesia together to praise and worship Him at His appointed times.

Over nearly 30 years, Jane became discouraged at the lack of understanding about why this is needed and the lack of response. She was weary from the battle and ready to give up. Hope deferred for 30 years makes the heart sick and in January of 2022 she had a sudden heart failure and was in a coma for 3 days.

She found herself on the other side of the veil with God, in a 3-day visitation where she was reminded of her calling and God's desire for ongoing, unified, corporate worship in NYS. She was then given a choice to go home or to return. She wanted to stay there but knew she had not finished her course so she asked for God's will and was immediately returned to her body with new faith and determination to carry out God's desire.

During recovery, the Lord reconnected Jane with a friend and fellow worshipper, June Schuldt, from the Harp and Bowl ministry in Albany. June is now assisting Jane in this initiative. They both also create praise and worship music for a NY statewide apostolic/prophetic ministry.

At the end of November, 2024, the Lord spoke that it is time to implement His vision in NYS and that the groundwork is to be in place January 2025. By God's grace we were able to put the groundwork in place and launched NYS Altars of Worship near the end of January.

Again, there was a lack of response. But rather than allow discouragement to come back in, Jane fasted and prayed the entire month of August of 2025. The Lord spoke many things but the main thing was Zechariah 4:10 (NLT) *"Do not despise these small beginnings, for the LORD*



rejoices to see the work begin..." He reassured her that He would make His vision happen, and told her to do as He instructs, to not listen to false counsel rooted in fear, and to be bold.

He also said that He wants statewide corporate worship at His appointed times in New York State and that it would be a prototype for the rest of the nation and nations. God's appointed times are monthly First Fruits as well as the Spring and Fall Feasts. Altars of Worship will cover monthly worship in every region and eventually in every county. One Voice statewide worship will be held in the Spring and Fall.

It is our duty as kings, priests, and stewards of NYS to minister to the Lord first and foremost. Altars of Worship is not our ministry. It is the required ministry of the Ecclesia. We are believing in radical faith that God will have His desire for ongoing, unified, corporate worship in New York State and we need YOU to help make it happen.
